- 1. Under the terms of the Key Employees' Deferred Compensation Program (the "Program"), the Reporting Person has chosen to make deferrals to an incentive account. - 3. The number of Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$27.48, which is the average trading price of BCO common stock for the month of March 2013, calculated in accordance with the terms of the Program.
