- 4. Units representing shares of BCO common stock were credited to the Reporting Person's account under the Program as a result of a dividend payment, in accordance with the terms of the Program.
- 5. The number of Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$22.64, which is the average trading price of BCO common stock on December 1, 2009, calculated in accordance with the terms of the Program.
