- The reporting person has elected to receive shares of BCO common stock as part of his quarterly compensation for service on the Company's Board and Committees and has elected to defer those shares under the Plan.
- The number of Units credited to the Reporting Person's equity account on the Transaction Date is based upon a share price of \$52.05, which is the closing price of BCO common stock on the final trading day of the quarter, calculated in accordance with the terms of the Plan.
